Christine shared a presentation on the Resilience Plan Progress Update for first quarter. She explained how it fits within our current strategic plan and priorities: Technology & Virtual Programming; Volunteer Support; Diversity and Inclusion; Board & Staff.

#### 8.3 Youth Advisory Committee (YAC) – 4-H Canada

Logan Emiry, outgoing YAC Rep, and Kayla Emmerton, incoming YAC Rep, joined the Council Meeting.

Logan gave a report highlighting his experiences this past year on YAC, and as Chair for the Youth Advisory Committee. There are two new YAC representatives and eight returning members this coming year. Logan attended the 4-H Canada Leadership Summit last month and the YAC Committee helped with some of the sessions. Logan is looking forward to his next chapter as a 4-H Leader.



Dennis Carnegie thanked Logan for representing 4-H Ontario and for providing updates to the Board over the last two years.

Dennis welcomed Kayla to the YAC position. Kayla told a little bit about herself, her 4-H experiences and how excited she is to represent 4-H Ontario in this role. Kayla attended the Leadership Summit, and a couple of YAC Meetings, including a Citizenship Congress planning meeting.

The Committee work plan will focus on data sharing, governance training, cost sharing, strategic priorities and provincial sharing. Leadership Development will be a component of the committee and they plan to meet four times a year.
