Membership billing occurs where the Association has a subsidy program and charges a fee less than the provincial youth participant fee. 4-H Ontario will bill the Association for the difference on a monthly basis with net 30 terms. An Association that has not paid its provincial youth participant fee by May 30th for the first quarter of the year and by September 30th for the second quarter, will not receive 4-H resources or awards and will forfeit the opportunity to send delegates to provincial

activities until the fees have been paid. Failure to retire outstanding invoices will also result in a suspension of voting privileges at the Provincial AGM.

Moved and seconded to approve the recommended changes to B-BO-19 Association in Good Standing.
